13. The licensee shall not open sealed sources containing radioactive material or remove sources from source holders, except as specifically authorized.
14. The licensee is authorized to distribute sealed sources and devices in accordance with the following sealed source and device (SSD) registrations, and the statements and representations included in the SSD registrations:
- A. TX-0426-D-108-G dated October 28, 2021, for the Ludlum Measurements, Inc. model 299-7.
15. The licensee is authorized to redistribute sealed sources and devices made by other manufacturers and registered in accordance with 25 TAC §289.252(v) or equivalent NRC or Agreement state rule.
16. The licensee is authorized to perform radiation survey instrument calibrations. The calibrations shall be performed in accordance with procedures described in application dated July 29, 2020.
17. The licensee shall maintain the financial assurance Surety Bond for \$113,000.00 current and in good standing.
